AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Lopez Island Hospital District from April 25, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Review of formation documentation
- Open public meetings minutes
- Evaluated design of controls for disbursement system
- Fiscal sustainability prior to receipt of property tax revenue in 2018

INFORMATION ABOUT THE DISTRICT

The San Juan County Public Hospital District No. 2, doing business as Lopez Island Hospital District, was formed by a special election of Lopez Island citizens in April 2017. It is governed by an elected five member Board of Commissioners and day to day administrative operations are overseen by a single employee. The District entered into agreements with UW Medicine to run a primary care clinic known as UW Medicine Lopez Island Clinic and with the newly created Lopez Island Physical Therapy LLC.

For the 2017 calendar year, which was the first year of District operations, there were total expenditures in the amount of \$390,742. District revenues are generated by property tax, which became available in 2018. Prior to property tax revenues becoming available, the District secured an interlocal loan from San Juan County and closed a Limited Purpose General Obligation Bond.
